In 1829, due to frequent mail mix-ups with Ridgeville, a town near Dayton, the postmaster general requested that the post office be named North Ridgeville. What was once a small farming community began to grow and prosper, and by 1958, North Ridgeville was incorporated as a village; two years later it became a city. Today the population nears 30,000, and North Ridgeville is flourishing, thanks to the hard work, determination, and pride of its forefathers.
