THEY TYPICALLY POSSESS SUBSTANTIAL FINANCIAL RESOURCES TO SURVIVE ECONOMIC DOWNTURNS. THEY ARE ALSO GENERALLY LEADERS IN THEIR INDUSTRIES. THIS GIVES THEM A SMALLER AMOUNT OF GROWTH OPPORTUNITY.
