CONSISTENT WITH PREVIOUS EVIDENCE FROM REGRESSION-BASED TESTS, MOST OF THE MODELS THAT WE EXAMINE ARE REJECTED BY OUR VOLATILITY-BASED TESTS. IN GENERAL, HOWEVER, WE FIND THAT EXCHANGE RATES HAVE NOT BEEN EXCESSIVELY VOLATILE RELATIVE TO MOVEMENTS OF THEIR DETERMINANTS, WITH RESPECT TO THE PREDICTIONS OF EVEN THE MOST RESTRICTIVE VERSION OF THE MONETARY MODEL. ALTERNATIVE MEASURES OF "VOLATILITY", HOWEVER, MAY DISGUISE THE CAUSE OF REJECTION AS EXCESSIVE EXCHANGE RATE VOLATILITY. IN OTHER WORDS, THE CURE FOR EXCHANGE RATE VOLATILITY IS WORSE THAN THE DISEASE. THIS FINDING IS DEMONSTRATED IN ECONOMIC MODELS, IN HISTORICAL CASE STUDIES, AND IN STATISTICAL ANALYSIS OF THE DATA. THE BOOK DEVOTES CONSIDERABLE ATTENTION TO UNDERSTANDING THE REASONS WHY VOLATILE EXCHANGE RATES DO NOT DESTABILIZE INFLATION AND OUTPUT. THE BOOK CONCLUDES THAT MANY COUNTRIES WOULD BENEFIT FROM ALLOWING GREATER FLEXIBILITY OF THEIR EXCHANGE RATES IN ORDER TO TARGET MONETARY POLICY AT STABILIZATION OF THEIR DOMESTIC ECONOMIES. FEW, IF ANY, COUNTRIES WOULD BENEFIT FROM A MOVE IN THE OPPOSITE DIRECTION.
