WE BEGIN WITH THE RECONSTRUCTION ERA LAWS, PASSED SHORTLY AFTER THE CIVIL WAR, THAT REMAIN AN IMPORTANT PART OF THE CIVIL RIGHTS LANDSCAPE EVEN AFTER CONGRESS ENACTED ADDITIONAL STATUTES, BEGINNING WITH THE CIVIL RIGHTS ACT OF 1964. THE MATERIALS INCLUDE TITLES II AND VII OF THE CIVIL RIGHTS ACT OF 1964, THE AGE DISCRIMINATION IN EMPLOYMENT ACT, THE AMERICANS WITH DISABILITIES ACT, AND THE EQUAL PAY ACT, AS WELL AS THREE FEDERAL FUNDING STATUTES THAT PROHIBIT DISCRIMINATION--THE REHABILITATION ACT OF 1973, TITLE VI OF THE CIVIL RIGHTS ACT OF 1964, AND TITLE IX OF THE EDUCATION AMENDMENTS OF 1972. SOME OF THE STATUTES OVERLAP AND WE EXPLORE THE ADVANTAGES AND DISADVANTAGES OF EACH, LOOKING AT THE ENFORCEMENT OPTIONS, REMEDIES, INCLUDING DAMAGES AND ATTORNEY FEES, DEFENSES, AND LIMITATIONS ON THE POWER OF CONGRESS TO PASS SUCH ACTS. MORE THAN THIRTY PROBLEMS PROVIDE THE STUDENTS WITH AN OPPORTUNITY TO APPLY THE STATUTES THEY STUDY. ABOUT THE AUTHORS: THE AUTHORS, ROSALIE BERGER LEVINSON AND IVAN E. THIS PRIVACY-BASED PROTECTION WAS NOT LIMITED TO ANONYMOUS PRIVATE CITIZENS BUT APPLIED TO FAMOUS ACTORS, ATHLETES, AND POLITICIANS. BEGINNING IN THE 1950S, THE RIGHT TRANSFORMED INTO A FULLY TRANSFERABLE INTELLECTUAL PROPERTY RIGHT, GENERATING A HOST OF LEGAL DISPUTES, FROM CONTROL OF DEAD CELEBRITIES LIKE PRINCE, TO THE USE OF STUDENT ATHLETES' IMAGES BY THE NCAA, TO LAWSUITS BY USERS OF FACEBOOK AND VICTIMS OF REVENGE PORN. THE RIGHT OF PUBLICITY HAS LOST ITS WAY. ROTHMAN PROPOSES RETURNING THE RIGHT TO ITS ORIGINS AND IN THE PROCESS RECLAIMING PRIVACY FOR A PUBLIC WORLD.
