Visits to centres for the vocally handicapped in the United States of America and Britain established that lack of flexibility was the greatest problem with existing speech aids. In an attempt to address the requirements, software-

generated key images (softkeys) and touchscreen technology were investigated by developing software models on a Hewlett Packard 150 computer. By having the input device and visual display physically combined, versatile but compact interfaces can be designed. A coding scheme can be used to give access to a large vocabulary without the user having to remember arbitrary key sequences in the traditional way. Tree structures allow fast manipulation of screen menus and, accordingly, treebased user interfaces were designed and tested. By focussing attention on one small area at any one time, the user is less likely to become confused. If that area is further controlled to adapt to the ability of the individual, the common problem of alienation is less likely to occur. Software models allow aphanumeric and iconic symbols to be easily constructed and added to screen key images. The facility exists for a speech therapist to draw icons directly onto a screen. These pictorial components are then automatically condensed according to the size of the keys they represent. Tests and refinements on these models resulted in two patent applications being drawn up and submitted. Questionnaires sent to speech therapists throughout Britain as well as research material presented at Communications Aid Centres and international conferences produced a positive exchange of ideas. Finally, the integration of software model criteria with touchscreen technology, flat panel displays and computer-controlled speech selection resulted in the development of working prototypes. Special versions permit quadriplegics and people with gross hand tremor to have the benefits of fast configuration. The technique used for screen scanning is believed to be unique; once the current screen softkeys have been scanned with a moving cursor, another screen is automatically displayed.

Without literacy skills, people with SSI are unable to use orthographic-based communication systems effectively to compose novel words and messages in spontaneous conversation. To address this problem, previous research has proposed the use of phoneme-based communication systems, which enable users to access a limited set of spoken phonemes (i.e. speech sounds). By combining sequences of phonemes, novel linguistic items can be constructed without knowledge of orthographic spelling. Despite this, phoneme-based

The few published reports on existing phoneme-based systems have highlighted a number of usability issues, including poor communication rate, difficult access methods to target phonemes, and high learning demands. To address these issues, this research aimed to investigate whether prediction methods could be employed to facilitate phoneme entry and the word creation process. Although prediction methods have been extensively applied in orthographic-based communication systems for rate enhancement, very limited research has been conducted on the potential of such methods to improve the usability of phoneme-based communication systems. This thesis describes the development and evaluation of a novel phoneme-based predictive communication system. The system utilised robust statistical language modelling techniques to perform context-dependent phoneme prediction and phonemebased word prediction. The usability of these phoneme-based predictive methods was assessed through a series of evaluation studies, including computational experiments with simulated interfaces, formative evaluations with sixteen non-disabled participants, and longitudinal case studies with two adults who have cerebral palsy and limited literacy. Results of these evaluations demonstrated that the predictive methods led to substantial improvements in user performance, both in terms of entry rate and accuracy. Data from a comparative evaluation with a nonspeaking male adult showed that his entry rate increased from 1.14 words per minute (WPM) without prediction to 4.19 WPM with prediction, while his error rate reduced from 50.0% word error rate (WER) without prediction to 0.0% WER with prediction. Results of a comparative study with a nonspeaking female adult reported that her performance improved from 0.37 WPM (79.17% WER) without prediction to 2.89 WPM (0.0% WER) with prediction. In addition, positive results of the case studies evidenced the potential of phoneme-based predictive communication systems to effectively

support nonspeaking individuals with literacy difficulties in generating novel linguistic items.
