In the state of Florida, a popular law known as Charlotte's Web bill was named after a particular medical marijuana strain known to have low THC and high CBD content, but the law itself doesn't specify that a specific strain should be used. In May 2014, Minnesota also passed limited medical marijuana legislation. The legislation doesn't include people getting access to whole plant medicines in whatever form, but only concentrates or extracts and the actual smoking is not permitted.
