THIS BOOK, PRODUCED BY A GROUP OF ECONOMISTS AND LAWYERS, ADOPTS A DIFFERENT APPROACH AND STARTS FROM FIRST PRINCIPLES IN ORDER TO GENERATE AN INTERNATIONAL TAX SYSTEM FIT FOR THE 21ST CENTURY. THE IMPLICATION IS THUS THAT IN OECD COUNTRIES BROADENING THE VAT BASE THROUGH FEWER REDUCED RATES AND EXEMPTIONS IS MORE CONDUCIVE TO HIGHER LONG-RUN GROWTH THAN A RISE IN THE STANDARD RATE.
