Croatia and the European Union Pero Maldini, Davor Paukovi?, 2016-03-09 The accession of Croatia to the EU marked the end of a long and arduous period of transition. Croatia had to meet significantly higher criteria than previous states with suspicion and concerns among existing members about further enlargement increasing. Meanwhile initially strong public support in Croatia declined as inconsistencies in EU policy, entry criteria and problems caused by the economic crisis all combined with fears about the loss of national identity and the ability to realize national interests. The successful Croatian accession to the EU in 2013 shows that, despite concerns on both sides, the EU continues to have meaning and significance and that membership remains highly desirable. Through nine mutually interrelated chapters the contributors speak not only about the political and social situation in Croatia, but also prospects for the European Union itself.

Talent Development in European Higher Education Dr. Marca V.C. Wolfensberger, 2015-02-10 This book examines the much-debated question of how to unleash the potential of young people with promising intellectual abilities and motivation. It looks at the increasingly important topic of excellence in education, and the shift in focus towards the provision of programs to support talented students in higher education. It provides a systematic overview of programs for talented students at northern European higher education institutions (HEIs). Starting in the Netherlands, where nearly all HEIs have developed honors programs over the past two decades, the book explores three clusters of countries: the Benelux, the Nordic and the German-speaking countries. With advances in technology making the copying of artworks and other artefacts exponentially easier, questions of copying no longer focus on the problems of forgery: they now expand into aesthetic and ethical legal concerns. Dazu werden zu Beginn die aktuellen Verfahren zur Gewichtsreduktion bei der Behandlung einer Adipositas erläutert. Tierethik im christlichen Religionsunterricht Janine Hoffmann, 2023-07-06 Tiere spielen eine wichtige Rolle im Leben von Menschen, insbesondere von Kindern. Ob als Haustier, faszinierendes Wildtier oder auf dem Teller - um tierethische Fragestellungen kommen Heranwachsende nicht herum. Der praktische Teil stellt eine Bestandsaufnahme und Leerstellenanzeige tierethischer Ansätze in Religionsschulbüchern und Lehrplänen dar. Die Arbeit bietet damit auch einen Überblick über Möglichkeiten und Herausforderungen in der tierethischen Diskussion aus christlich-ethischer Sicht.
