conditions, each subject was given 60 trials in which he was required to make and execute a decision to pass or to continue following a lead car. Times available to safely complete a pass and vehicle speeds were presented in a random manner. During the alcohol condition, subjects not only attempted and completed significantly more passes but also experienced more accidents. Results of this experiment suggest that the effects of moderate levels of blood alcohol must be examined not only as they affect perceptual motor skills, but also as they may more subtly affect risk-taking behavior and decision processes involved in operating a motor vehicle.
