This law marks an epoch in the history of English marriage legislation. It was felt that something must be done to permit dissenters to marry according to their own fashion. Even to the clergymen of the Established Church there was something unpleasant in being compelled to unite people by means of forms and ceremonies for which they had not the slightest reverence. Lord John Russell introduced the bill, the object of which, he said, was to permit every one to be married according to whatever form his conscience dictated.
