Financial Incentives for Increasing Work and Income Among Low-income Families Rebecca M. Blank,David Edward Card,Philip K. Financial incentive programs appear to increase work and raise income (lower poverty), but cost somewhat more than alternative welfare programs. Several existing programs limit this effect by targeting long-term welfare recipients or by limiting benefits to full-time workers. At the same time, because financial incentive programs transfer support to working low-income families, the increase in costs due to windfall beneficiaries makes these programs more effective at alleviating poverty and raising incomes.
