However, with habitat degradation continuing and sometimes increasing in rate, it is now clear conservation alone will not be sufficient to protect and reestablish coastal ecosystems. Habitat restoration, although in existence for many decades, has recently been elevated as a new primary strategy to stem and even reverse coastal habitat loss. The call for increasing investment in restoration efforts has emerged with significant advances in propagule rearing and dispersion of habitat-forming organisms (e.g., oysters, seagrasses, corals). In addition, restoration resources are increasingly allocated by governments and/or large corporations with the aim to, for example, fix past landscape engineering efforts that had unintended environmental consequences. Such investments are being made to (i) provide jobs for those unemployed during economic downturns, (ii) restore ecosystems destroyed by natural disasters and stressors, (iii) increase coastal defense in response to increased frequency of intense storms, and/or (iv) compensate for pollution-and development-driven habitat degradation.
