On November 15, 2007, OSHA issued a final rule for Employer Payment for Personal Protective Equipment that applies identical PPE payment requirements to workplaces in all industries, including those covered by the general industry standards. In addition, OSHA is amending its provision that requires safety shoes to comply with a specific American National Standards Institute (ANSI) standard.
