improve maternal and child health indices in sub-Saharan Africa and further reduce the disease burden due to indoor air pollution in general, the author recommends the following: - Increase availability of data on concentrations of indoor air pollution to aid in planning and development of national standards in sub-Saharan Africa. - Reinforce regulatory policies on clean energy use at household level and emissions in general. - Scale up research in and use of emerging low-cost sensors for assessing indoor air pollution periodically. - Raise levels of awareness among populations, especially women and children on adverse health effects of biomass use in sub-Saharan Africa.
