The largest effect of structural reforms, involving regulatory changes that promote competition and facilitate flexible forms of employment, comes through the productivity/efficiency channel. Pro-competition regulation also improves labor utilization, while lower entry barriers and trade tariffs are important for capital accumulation. Structural reforms could have substantial effects on Argentina's long-term GDP growth; for example, an ambitious reform effort to improve business regulatory environment would add 1-11/2 percent to average annual growth of GDP.
