WHETHER THE GOVERNMENT ADMITS IT OR NOT TRAFFIC TICKETS ARE A WONDERFUL WAY TO RAISE REVENUE. AND WITH THE COUNTRY IN AN UNDENIABLE FINANCIAL PANIC AND NEAR BANKRUPTCY, WHAT BETTER WAY TO QUASH THE FINANCIAL FEARS THAN BY ROBBING ITS CITIZENS.
