incarnation, but still with a waterfront view (the Atlantic Ocean). In between, it has visited some picturesque views of other lakes and bays of the world: Palo Alto (1990 - San Francisco Bay), Stockholm (1993 - Baltic Sea), Vancouver (1994- the Strait of Georgia and the Pacific Ocean), and Sophia Antipolis I Nice (1996- the Mediterranean Sea). PfHSN is a workshop providing an international forum for the exchange of information on high-speed networks. It is a relatively small workshop, limited to 80 participants or less, to encourage lively discussion and the active participation of all attendees. A significant component of the workshop is interactive in nature, with a long history of significant time reserved for discussions. This was enhanced in 1996 by Christophe Diot and W allid Dabbous with the institution of Working Sessions chaired by an animator, who is a distinguished researcher focusing on topical issues of the day. These sessions are an audience participation event, and are one of the things that makes PfHSN a true working conference.

The book also examines the extent to which Moroccan citizens have benefited from the economic transformations, arguing that not all Moroccans have benefited; many Moroccan citizens in 2019 echo the same economic concerns that were voiced in 1999 when King Mohammed VI first assumed the throne. of Middle East and North African Studies, but also Economics, International Development, and Politics.
