*Pursuing the Spiritual Roots of Protest* Gordon Oyer,2014-02-28 In the fall of 1964, Trappist monk Thomas Merton prepared to host an unprecedented gathering of peace activists. About all we have is a great need for roots, he observed, but to know this is already something. His remark anticipated their agenda--a search for spiritual roots to nurture sound motives for protest. This event's originality lay in the varied religious commitments present. Convened in an era of well-kept faith boundaries, members of Catholic (lay and clergy), mainline Protestant, historic peace church, and Unitarian traditions participated. Ages also varied, ranging from twenty-three to seventy-nine. Several among the fourteen who gathered are well known today among faith-based peace advocates: the Berrigan brothers, Jim Forest, Tom Cornell, John Howard Yoder, A. J. Muste, and Merton himself. **Gifts** Richard Hyland,2009-06-05 Gifts: A Study in Comparative Law is the first broad-based study of the law governing the giving and revocation of gifts ever attempted. Gift-giving is everywhere governed by social and customary norms before it encounters the law and the giving of gifts takes place largely outside of the marketplace.
