Explanation 1.-Income accruing or arising outside India shall not be deemed to be received in India within the meaning of this section by reason only of the fact that it is taken into account in a balance sheet prepared in India. Explanation 2.-For the removal of doubts, it is hereby declared that income which has been included in the total income of a person on the basis that it has accrued or arisen or is deemed to have accrued or arisen to him shall not again be so included on the basis that it is received or deemed to be received by him in

There were many amendments from time to time, at last a separate Income Tax Act was passed in 1886. This Income Tax Act was replaced by Income Tax Act, 1918, which was further replaced by Income Tax Act 1922. Income Tax Act of 1922 was subject to many amendments over a period of time due to which it became very complicated. Therefore in order to simplify and to plug loopholes the government of India referred the matter to law commission in 1956, which submitted its report in September, 1958. But in the meantime the government of India constituted Direct Tax Inquiry Committee which submitted its report in 1959. Finally in consultation with ministry of law the Income Tax Act, 1961 was enacted which applied to whole of India. Income Tax Act, 1961 has also been subject to many amendments over a period of time either through Finance Act as passed by the Parliament every year or by separate amendment Acts.
