### ***Communication Strategies in Turkey* Taner Dogan, 2020-12-10**

The Turkish President Recep Tayyip Erdogan is known for his populist Islamist ideology, charismatic personality, and for ushering in new forms of communication strategies in Turkey. The key tools in Erdogan's political communication repertoire include religious, cultural and historic symbols and imagery. From engaging Israel to the Gezi Park protests, from the Arab uprisings to the July 2016 coup attempt, every key moment in Turkey's recent history has heralded a change in Erdogan's rhetoric. *Communication Strategies in Turkey* examines the transformation of political messaging that has taken place within the Justice and Development Party (AKP) under Erdogan. Using quantitative and qualitative analysis of in-depth interviews with high profile AKP officials, observations at AKP rallies and headquarters, and analysis of Erdogan's speeches from 2002 to 2019, the book shows how his method of communication changed over time to prioritise a "New Turkey" to replace Atatürk and his legacy.

### **Turkey's Pivot to Eurasia** Emre Erşen, Seçkin

Köstem, 2019-05-21 This book discusses and analyses the dimensions of Turkey's strategic rapprochement with the Eurasian states and institutions since the deterioration of

Ankara's relations with its traditional NATO allies. Do these developments signify a major strategic reorientation in Turkish foreign policy? Is Eurasia becoming an alternative geopolitical concept to Europe or the West? Or is this 'pivot to Eurasia' an instrument of the current Turkish government to obtain greater diplomatic leverage? Engaging with these key questions, the contributors explore the geographical, political, economic, military and social dynamics that influence this process, while addressing the questions that arise from the difficulties in reconciling Ankara's strategic priorities with those of other Eurasian countries like Russia, China, Iran and India. Chapters focus on the different aspects of Turkey's improving bilateral relations with the Eurasian states and institutions and consider the possibility of developing a convincing Eurasian alternative for Turkish foreign policy. The book will be useful for researchers in the fields of politics and IR more broadly, and particularly relevant for scholars and students researching Turkish foreign policy and the geopolitics of Eurasia.

**Neoliberal Transformation of Electricity** Serhan

Ünal, 2023-05-02 This book makes a structural analysis of the neoliberal restructuring in the global electricity industry. The book shows that the electricity liberalisation in different countries is just a reflection of the same structural trend in the global economy and avoids from both narrow country-specific and abstract global approaches by making a structural analysis completed by a case study. Thus, it aims reaching wider conclusions about how global changes in finance and ideology / knowledge structures influence domestic energy and economic policy preferences of developing countries. The book develops a taxonomy about organising principles around which the electricity industry has been structured historically and globally, and reveals drivers of change which influences the current energy transition in the electricity sector. Combining these aspects, the book uses financial and other economic data

empirically, to shed light on the structural role of global transformation of the electricity markets on the domestic energy policy preferences of the developing countries. Thus, this work will be useful not only for academic purposes, but also for practitioners dealing with these issues.

*Disciples of the State?* Kristin Fabbe, 2019-03-28 As the Ottoman Empire crumbled, the Middle East and Balkans became the site of contestation and cooperation between the traditional forces of religion and the emergent machine of the sovereign state. Yet such strategic interaction rarely yielded a decisive victory for either the secular state or for religion. By tracing how state-builders engaged religious institutions, elites, and attachments, this book problematizes the divergent religion-state power configurations that have developed. There are two central arguments. First, states carved out more sovereign space in places like Greece and Turkey, where religious elites were integral to early centralizing reform processes. Second, region-wide structural constraints on the types of linkages that states were able to build with religion have generated long-term repercussions. Fatefully, both state policies that seek to facilitate equality through the recognition of religious difference and state policies that seek to eradicate such difference have contributed to failures of liberal democratic consolidation.

*Neoliberal Turkey and its Discontents* Fikret Adaman, Bengi Akbulut, Murat Arsel, 2017-05-30 The 'neoliberal' economic policy of President Recep Tayyip Erdogan's AKP Party, which has delivered extraordinary growth in Turkish GDP over the last decade, has been one of the foundations of the party's popular appeal. Here, a group of experts on Turkish political economy show how these policies have also had a detrimental impact on the environment, sustainability and the long-term health of the Turkish economy. Taking the two main sectors of growth during the past decade-energy and construction-as its primary focus, the book engages broadly with the political economy of inequality and

sustainability in contemporary Turkey. Ultimately, the authors argue that 'environmental conflicts' in Turkey are not merely about the environment but intersect with contemporary politics of religion, ethnicity, gender, and class within the context of top-down, modernising economic development. *Neoliberal Turkey and its Discontents* marks an important contribution to debates around the economic growth of Turkey and the future of the AKP's long-term economic plan.

**Turkey, the EU and the Middle East** Buğra

Süsler, 2020-02-24 This book focuses on the dynamics of Turkey's relationship with Europe in the context of the 'Arab Spring' and analyses Turkish behaviour vis-à-vis foreign policy cooperation with the EU. Süsler explains the complexity of Turkey-EU relations by looking beyond membership negotiations and examines informal foreign policy dialogue between Turkish and EU officials. The book discusses the reactions of the Turkish government to the uprisings in Libya, Syria, and Egypt and cooperative opportunities between Turkey and the EU. The analysis finds that although cooperation varies across cases, foreign policy dialogue has become a main driver of the Turkey-EU relationship. A counter-intuitive finding of the research is that the EU has often been the actor seeking Turkey's cooperation, rather than the other way round, clearly challenging the original power asymmetry between Turkey and the EU. Based on interviews with diplomats and policy makers and extensive documentary research, this book will be of interest to political scientists, students, policy makers and researchers focusing on Turkish foreign policy and Turkey-EU relations. This book is also about exploring inventive ways of maintaining a complex working partnership with the EU and will be of interest to scholars working on the EU's relationship with outsiders.

Democracy and Justice Agnes Czajka, 2016-11-03 This book explores the possibilities offered by Derrida's work on democracy for interpreting contemporary struggles over democracy in

Turkey. The relationship between democracy and justice seems of unquestionable importance to Derrida, with democracy and justice held in tension by deconstruction. Agnes Czajka offers a qualified endorsement of a 'just democracy', grounded in the possibilities opened up by reading Derrida's work on democracy together with his work on justice. She posits that one way of imagining democracy-to-come might be to imagine it as a 'just democracy', or one poised at the intersection of the aporia of democracy and the (non)imperative to justice. In the particular context of contemporary struggles over democracy in Turkey, she also explores what such comportment toward a just democracy (or a justice of/in democracy) might look like in the context of that 'particular' democracy.

**A Transnational Account of Turkish Foreign Policy** Hazal Papuççular, Deniz Kuru, 2020-05-25 This book offers an analysis of Turkish foreign policy based on transnational(ist) perspectives. In order to counterbalance the state-centric accounts that dominate this area of study, the authors provide theoretical frameworks as well as historical and contemporary case studies that emphasize transnational dynamics. The content is divided into four complementary sections that explain and exemplify transnational (f)actors in the context of Turkish foreign policy. The first addresses theoretical and ideational frameworks that illustrate the relevance of a transnational account, while the second demonstrates the possibility of developing transnationally oriented approaches even in historical cases, going beyond a presentist focus. In the third and fourth sections, the book focuses on two prominent non-state actors, namely diaspora communities and non-governmental organizations, which operate at the interstices of the domestic and the international. This allows the authors to highlight the significance of transnational dynamics in Turkey's foreign policy.

While Turkey has historically been important geopolitically, it has become an outlier in Europe and an uncertain ally of the United States. *An Uncertain Ally* is a straightforward indictment of Erdogan. Drawing on inside sources in his Justice and Development Party (AKP) and the police, the book reveals corruption and money laundering schemes that benefitted Erdogan, his cronies, and family members. Erdogan has polarized Turkish society and created conditions that led to the coup attempt of July 2016. Under Erdogan, Turkey faces a dark future that poses a danger to the region and internationally.

**Queer in Translation** Evren Savci, 2020-12-14 In *Queer in Translation*, Evren Savcı analyzes the travel and translation of Western LGBT political terminology to Turkey in order to illuminate how sexual politics have unfolded under Recep Tayyip Erdoğan's AKP government. Under the AKP's neoliberal Islamic regime, Savcı shows, there has been a stark shift from a politics of multicultural inclusion to one of securitized authoritarianism. **Classifying Foreign Fighters: The Case of YPG** Mehmet Furkan ERGÜL, Foreign fighters and returning foreign fighters are among the most important security issues that the Middle East and Europe is facing today. Although this topic has gained more attention in recent years, most of the academic studies on foreign fighters do not focus on the issue of classification. This book is based on a master's thesis and focuses on this somewhat neglected area of research by analyzing the discourse of foreign YPG fighters and finally proposing a classification for foreign YPG fighters based on their narratives. David Malet's PhD dissertation, which categorizes foreign fighters into four different types is particularly important and this study is based on Malet's classification. However, unlike Malet's thesis, this study focuses on one armed organization, the YPG, instead of a general categorization.
