Both the decomposition of the group $[B,C]_{\mathcal{G}}$ and the splitting of the cofibre sequence are proven here not just for complete G -universes, but for arbitrary G -universes. These include versions of the Adams and Wirthmuller isomorphisms for incomplete universes.
