The aim of this project is to solve the efficiency and scalability problem of the Merger for the INQUERY indexing system. The speed performance of the old Merger (merge\_btl) degrades significantly when used in building big databases under tight memory space limitations. The authors have found a better solution by using a hierarchical merge approach. Timing tests on the new Merger indicates that merge time can be significantly reduced. Hierarchical merge nicely solves the problem of scalability and greatly improves the efficiency of building very large databases for information retrieval systems.
