Record companies had to put up with huge losses, and now on a sudden four years are gone since Napster sparked the P2P revolution in 1999.1 The increasing digitization of music and concomitant changes in music production and distribution are not reversible anymore. Astonishingly, record companies have not yet come up with models or strategies that use the advantages of this process successfully. Any attempt failed so far because they could not convince the most important stakeholder - the consumer.2 This paper concentrates on intelligent agent technology which has been promisingly

described as “[...] software that is proactive, personalized, and adapted. Software that can actually act on behalf of people, take in initiative, make suggestions [...]”³.
