THE IDEA THAT SELF-EMPLOYED CITIZENS ARE THE FOUNDATION OF DEMOCRACY IS A RELIC OF JEFFERSONIAN DREAMS OF AN AGRARIAN SOCIETY. AND GOVERNMENTS, MOTIVATED BY A CONFUSED MIX OF POPULIST AND FREE MARKET IDEOLOGY, IN FACT GO OUT OF THEIR WAY TO PROMOTE SMALL BUSINESS.
