The growing trend toward the use of more automated attack tools has also overwhelmed some of the current methodologies used for tracking Internet cyberattacks. This book provides background information for three types of attacks against computers (cyberattack, physical attack, and electromagnetic attack), and discusses related vulnerabilities for each type of attack. The book also describes the possible effects of a co-ordinated cyberattack, or computer network attack (CNA), against U.S. infrastructure computers, along with possible technical capabilities of international terrorists. Issues for Congress may include how could trends in cyberattacks be measured more
