Hedge Funds Vikas Agarwal,2015 Hedge funds have become increasingly important players in financial markets. This heightened importance has spawned a large academic literature focused on issues pertinent to hedge fund managers, investors, regulators, and policymakers. Although the top-4 finance journals (JF, JFE, RFS, and JFQA) published only 16 papers on hedge funds prior to 2005, they have published 105 papers on hedge funds since 2005.
