In 1947, the U.S. Air Force became independent of the Army and a National Military Establishment (which became the Department of Defense in 1949) was formed to coordinate and, after 1949, to control the services. Yet, disagreements over roles and missions continued, often exacerbated by the fiscal limitations of the post-war era. But not all roles and missions disagreements were caused by financial struggles. Genuine differences of opinion over doctrinal issues and the best means to accomplish missions often divided the services, and on many occasions the Secretary of Defense had to assign missions and adjudicate roles amid a blizzard of conflicting claims. 1.
