In these authors, the gods or fate tend to settle the outcome of the most significant events, but they leave leeway for the specific way in which these pivotal events come to pass. Thus, the Greeks endorsed a malleable variant of necessity, so that considerable scope for human choice persists within the framework fixed by necessity. Pericles turns out to be Thucydides' prime example of an individual who uses the leeway left by necessity for prudent interventions into the course of events.
