perform collaboratively a computation in the form of data matching with spatial predicates, for data mining tasks that enhance the user experience by synthesizing profiles, or increase the companies' revenue. Each party will contribute its own dataset of locations, but only in anonymized form, and only the results of the computation should be revealed to each party, without gai
