A transaction in general implants changes made in the real world in a physical database [1]. Therefore business transactions are multiple basic operations involving exchanges (cash, credit, information) that have financial implications, such as customer placing an order or someone paying parking tickets and they establish a connection between an organization and its database [3]. A TP system is a form of data base management system that processes business transactions [1]. Usually there exist several different systems in one organization. Examples of TP applications are payroll, inventory, order processing, reservations, account processing in banks, and stock trading [3].
