

SERVICES HAVE A RELATIVELY LOW CONTRIBUTION TO VALUE-ADDED IN GROSS EXPORTS. GIVEN THE HIGH INTEGRATION OF THE CZECH REPUBLIC INTO GLOBAL VALUE CHAINS, IT IS CRUCIAL TO TAKE SUPPLY CHAIN LINKAGES INTO ACCOUNT WHEN ASSESSING THE IMPACT OF TRADE SHOCKS. THE EXPOSURE TO GERMANY IS EVEN MORE PRONOUNCED AT THE SECTORAL LEVEL. MANUFACTURING OF MACHINERY AND TRANSPORTATION VEHICLES ACCOUNT FOR A LARGE SHARE OF EXPORTS AND IMPORTS IN THE CZECH REPUBLIC.
